



## Now is the time to send unarmed peacekeepers to Gaza and the rest of Palestine

Hundreds of unarmed civilian protectors could be quickly deployed to support Palestinians in securing a more sustainable peace than armed forces ever could.

When the U.N. Security Council finally passed a Ceasefire Resolution for Gaza by a vote of 14-0 — with the U.S. abstaining — on March 26, it was clear in its demand for a ceasefire, as well as several other key points, including the unconditional release of all hostages, the proper treatment of detainees in compliance with international law and access to humanitarian and medical aid. However, the UNSC was silent about how these demands might be enforced, thus rendering them more akin to suggestions.

That same day, an advance draft of a U.N. Human Rights Council report offered a glimpse at how such enforcement could actually happen, calling for the deployment of "an international protective presence" to help stem violence against Palestinians in Gaza and the rest of the Occupied Territories. The following day, the report's author — Special Rapporteur Francesca Albanese — expanded on her recommendation at a news conference in Geneva, saying that such an international protective presence should operate like the handful of NGO-affiliated unarmed civilians currently interposing themselves on the West Bank and in East Jerusalem. "This is the thing that should be done," she explained. "Making sure that pending the military withdrawal from the Occupied Territories, there is a shelter between the Palestinians and the armed settlers and army."

Albanese is correct: Now is the time to recruit, prepare and send large numbers of well-trained <u>unarmed civilian</u> <u>protectors</u> to the Occupied Territories of Palestine to support local civil society, directly protect civilians and bolster those already providing unarmed civilian protection on a small scale. While the U.N. Security and Human Rights Councils have created openings, we cannot wait for them to act. The Security Council could take months — if ever — to make a decision, and even then, it would be prone to

send armed peacekeepers. Unarmed civilian protection and accompaniment groups have, for years, been successfully carrying out the activities described by the UNSC and HRC. We must accelerate this people-to-people response.

As Special Rapporteur Albanese noted, Israeli, Palestinian and international groups have already been

providing unarmed civilian protection, or UCP, in other parts of Palestine. Facing intensified harassment and violence from settlers and the Israeli Defense Forces since Oct. 7, groups like Ta'ayush, Looking the Occupation in the Eye, the Center for Jewish Nonviolence and Community Peacemaker Teams continue to provide protective presence and support self-protection in the homes of Palestinians and at checkpoints, as well as by accompanying farmers and shepherds.

Recently, in response to <u>Israeli settlers blocking a Gaza aid convoy</u> arriving from Jordan at the Tarqumiya checkpoint, the Jewish and Palestinian grassroots movement <u>Standing Together</u> mobilized a Humanitarian Guard to accompany trucks carrying aid destined for Gaza. "There is always the risk that something physical might happen, of course, but engaging with the settlers is not our goal," Rula Daood, the national co-director of Standing Together <u>told Haaretz</u>. "Instead, we not only want to call attention to what is happening at the border crossing, we hope that our presence there will bring accountability to the police and the army."

On May 19, the Humanitarian Guard was able to block the settlers from the convoy at Tarqumiya checkpoint, with the police arriving promptly to move the settlers back. The group again helped remove settlers when they attacked the trucks at another junction. "Up to now all the food that went out today will get to Gaza safely," a Standing Together spokesperson reported. They will be going out every day to protect the trucks from settler attacks.

Haaretz <u>recently reported</u> on the stories of six Israeli activists who are trying to protect Palestinians in the West Bank. Hillel Levi Faur is part of a group of about 100 young people called Presence in Hard Times, which places Israelis in homes under threat in the South Hebron Hills. As Levi Faur stressed, "They keep pleading with us to come. There are communities that make you feel bad if you don't show up for a week or two. They say, 'We can't sleep.' It's terrible, having those conversations."

As part of her work for the Center of Jewish Nonviolence, <u>Katie Loncke reported</u> similar examples of deterrence through protective presence during her stay in Masafer Yatta, citing shepherds who were able to extend their grazing areas and a family that was able to return to their home.

The 2016 study "Wielding Nonviolence in the Midst of Violence" found multiple respondents reporting positive

impacts of unarmed civilian protection in the Palestinian territories, including enhancing Palestinian leadership and nonviolent resistance, helping people keep land and stay in their communities, decreasing violence toward Palestinian demonstrations, de-escalating violence by Israeli soldiers, decreasing violence by Palestinians, protecting

school children and decreasing checkpoint abuse. According to the study's findings, "Respondents consistently reported that UCP activity has diminished violence from soldiers, settlers and Palestinians."

The good news is that those already active groups are scaling up their efforts. The Center for Jewish Nonviolence is <u>recruiting individuals</u> to join 10-day Summer Solidarity Shifts to bolster the existing network

of solidarity presence. The Italian group Operazione Colomba is continuing to support the nonviolent struggle of the Palestinian communities south of Hebron, and the U.S. group Meta Peace Team is gearing up to send a team. Meanwhile, accompaniers from the World Council of Churches-sponsored Ecumenical Accompaniment Programme in Palestine and Israel are returning to their work in the West Bank.

## The opportunity

The 2016 study "Wielding

While the existing work is extremely important, it will have to be significantly scaled up in numbers and duration to address the needs of not only the West Bank, but especially Gaza. Fortunately, the human resources exist. Hundreds of veteran unarmed civilian protectors and accompaniers live in at least 35 countries and have worked with one or more of the 60-plus organizations practicing UCP and accompaniment. At least 20 of these organizations have already worked in the Occupied Territories of Palestine.

With sufficient funds (a fraction of the cost of any military intervention), they could be mobilized, provided updated training by Palestinians and deployed quickly. Working closely with local Palestinians and UCP groups on the ground, these veterans could effectively carry out the objectives in the Security Council Ceasefire Resolution and Human Rights Council report, including:

- protecting efficient provision of humanitarian assistance and medical care.
- · accompanying people under threat,
- interpositioning between conflicting parties,
- monitoring ceasefires,
- monitoring and reporting on compliance with international law, and
- providing direct protection to civilians.

Peace Brigades International, for example, has been, among other places, since 1994. The organization I helped to found, Nonviolent Peaceforce, has been opening humanitarian access for remote, difficult-to-reach places in South Sudan since 2011. The Swedish Fellowship of Reconciliation is among many UCP groups that — in addition to providing accompaniment and protective presence, as well as supporting communities in self-protection — monitors and reports on international law, for example arbitrary detentions in Mexico.

Nonviolent Peaceforce was also part of the ceasefire process in Mindanao from 2009-2014, having been invited by both the government of the Philippines and the Moro Islamic Liberation Front to be an official part of the International Monitoring Team. Reflecting on her work

with my former organization in Mindanao, Ambassador Kristine Leilani R. Salle from the Philippine Mission to the U.N. in Geneva said: "Our experience shows that civilianled nonviolent approaches can contribute to saving lives and empowering people in communities to build a just and lasting peace for themselves even under the most difficult of circumstances."

These veterans of UCP and accompaniment also have experience in applying a variety of other nonviolent methodologies, including de-escalation, early warning/early response and supporting community-based unarmed self-defense. What's more, they have extensive experience dealing with armed actors — whether they be warring governments or non-state actors like the Tamil Tigers in Sri Lanka, the Moro Islamic Liberation Front in the Philippines or the FARC in Colombia. Their goal is not to convert anyone — although sometimes that happens — but rather to be able to communicate with one another, lessen tensions, protect civilians and prevent violence.

## Violence as default

Despite the success stories cited above, many policy leaders are once again poised to spend billions of dollars for an armed peacekeeping approach in the Occupied Territories. On May 16, the Arab League passed the "Manama Declaration," calling for U.N. peacekeeping forces to be sent to the occupied Palestinian territories until a two-state solution to the Israel-Palestine conflict is implemented. This comes at the same time as the <u>U.N.</u> is withdrawing 13,500 peacekeepers from Democratic Republic of the Congo at the demand of the Congolese government, which says the peacekeepers have failed — after 20 years — to protect civilians from armed groups.

While armed peacekeepers can often keep other armed groups apart, they are neither trained, equipped nor good at community engagement, which is essential for



protecting civilians and building sustainable peace. Military peacekeeping forces are usually drawn from South Asian or African militaries — with their governments being paid for the service. They typically do not speak local languages and are not allowed to live in the community. Therefore, they

only have limited interactions with civil society.

Working with Nonviolent Peaceforce, I saw U.N. peacekeepers' lack of on-the-ground engagement in South Sudan. I even unsuccessfully advocated — with the U.N. Department of Peacekeeping — for their armed peacekeepers to protect women from assault by walking with them as they collected firewood in the bush. I was told that it would be too unsafe. This is something our unarmed teams did routinely for four years.

Because armed peacekeepers have limited engagement with local civil society which is a fundamental element in protection, the best they can offer is an imposed, temporary, top-down intervention. Rachel Julian of Leeds Beckett University observes in her forthcoming book on UCP, "Transforming Protection," that such top-down, armed approaches to protection assumes expertise and power are in the hands of a few outsiders, excluding local agency. "This means that what safety means to them, the diverse nature of the threats and the transformational change required are

not included. Transformational change requires a change in the power system," Julian concluded.

With the attack on Israeli civilians by Hamas on Oct. 7 or the targeted killing of World Central Kitchen staff by IDF drones on April 1, it is fair to ask why unarmed civilian protectors would be treated any differently. However, it's the international attention brought on by these very tragedies that may expand the protection internationals can provide. For example, in 1987, American engineer Ben Linder and two other humanitarian workers were killed by the Contras along the northern border of Nicaragua. His death elevated international outrage mobilizing hundreds of internationals to go Nicaragua, which in turn expanded a protective presence in rural areas.

While it is almost impossible for anyone to get into Gaza at the moment

— let alone a large group — pressures are building rapidly with the growing recognition of Palestinian statehood, the International Criminal Court issuing arrest warrants, the International Court of Justice ordering Israel to abide by the <u>Genocide Convention</u> and ceasefire negotiations still ongoing. At the same time, on the grassroots level, students around the world are pressing for divestment from Israel, the Freedom Flotilla is pushing for entry into Gaza and groups like Jewish Voice for Peace are organizing for a ceasefire and an end to military aid to Israel.

These diplomatic, legal and grassroots initiatives will intensify and continue to create cracks if not openings. We have to be ready to take advantage of them when they occur. If we wait to prepare until the opportunities are fully formed, militaries will have already been deployed. By demonstrating our readiness, we build the reality and pressure to use UCP.

Acting as a consortium, UCP groups can bring together a large-scale, experienced, well-trained international force of unarmed civilian protectors who have proven that they can protect civilians, deter violence, accompany hostages, protect the delivery of humanitarian assistance, protect homes, support community self-protection and assist the implementation of ceasefires. They can work closely with local civil society to build lasting peace. To have this resource available now, will only speed up the peace process.

## Learning to Listen to Palestine: A Personal Quest

A new book has been released that offers profound hope regarding the humanitarian crisis in Israel and Palestine. This crisis is bleak, sad, and seemingly hopeless. However, hope was found when author Lani Lanchester learned to listen to Palestine about a conflict that has spanned a century. Hope is hidden in many stories.

Lani Lanchester is a high school science teacher who shares, "No matter what our culture is telling us, scientifically, there is only one race. The human race." She also knows that you cannot teach someone who doesn't trust you. So, in her classroom, she is careful to build trust with each one of her students, and this requires her to listen to their stories.

Lani shares a story in her book: "Oftentimes, my African American students do not trust me because I look like someone who has been abusive to them. At some point, when we just are not working well together, I will point at the door and say, "In the hall." These are fighting words for some. The hall is where they expect more abuse. They expect to be belittled, dehumanized, and threatened with punishment. I find this horrible.

This is what I do: "Lean against the wall. Stare that way," I tell them. Then I lean against the wall next to them, neither of us looking at the other.

"What, what do you want?" the student may ask as their frustration, fear, or anxiety grows, turning toward me.

"We are leaning against the wall until I calm down. Just lean." I will explain. Soon, I feel myself again. I am not answering the situation in anger, and the student may become curious and more relaxed.

I look at the student and say, "I love you. That is my most important job, and I should not be here if I did not love you." This shocks and softens my student to the next thing that I offer. "We are not working well together, but we have a job to do. To give you the best life possible, we need to be on the same side."





At this point, I must be open to hearing the student. There is something wrong. Perhaps it was something that I said that triggered them. Perhaps it was simply because I looked like someone who hurt them in the past. Sometimes, students at this point, will start telling me something very important that someone must know and care about for them to have a chance to succeed. The key is to convince them that I care, that I am on their side, and that there is only one

side in my classroom.

Lani's story continues by shaking all her beliefs and what she thought she knew about the land of Israel and Palestine. "I was getting ready to go to Israel by myself on a road trip tour of Israel."

"As I was preparing to go, I read about Shireen Abu Akleh. Shireen was almost exactly my age, 51 years old. She was a Palestinian Christian who earned her citizenship in the United States. She went to school here and worked here, but she returned to Israel and Palestine to report on what was happening between Israel and Palestine. She had covered the Israeli-Palestinian conflict for 25 years.

However, on May 11, 2022, Shireen Abu Akleh was targeted by an IDF (Israeli Defense Force) sniper and shot in the head. The IDF denied this for a few weeks but, in

the end, admitted to the crime. The incident was caught on film, and there were many witnesses. Forensic evidence was gathered. Nevertheless, no one was held accountable for her death.

This brought me into full, crushing confusion. I thought I knew Israel. I knew nothing. I did not understand why I had not heard about this tragedy before from the press. I did not understand why the US government had not called for accountability and justice. I did not understand how the IDF, which was supposed to be keeping people safe, could have so blatantly murdered this woman who served by only telling the truth. "

This was the first of many stories that made Lani pay attention and start to listen. While traveling up a winding road in Israel with her Palestinian friend, Lani recalls that she ignorantly said, "There must have been something righteous about 1948."

Her friend stopped the car. He said, "Righteous?! 530 villages were destroyed. There were massacres, rapes! They killed men, women, and children! 750,000 people were forced out of their homes. The Israelis plant trees over ruined villages and massacres to hide the evidence."

Lani had never heard this before. None of it. She was shocked to her core. This began a quest to learn what was

true. Learning was difficult. Much of the evidence is deeply hidden. Eyewitnesses are readily available to share personal stories and want to be heard. Every step revealed more myths in her beliefs and more hidden abuses perpetrated on the Palestinian people.

But Lani did not just learn about horrible things. She learned that Palestinians are a resilient, beautiful people with rich culture, heritage, family, and values. As she was learning to listen, she was always welcomed into a warm, kind, familial atmosphere. Palestinian culture has much to offer the world in love and peace.

Most importantly, Lani Lanchester has found a new hope in peace. Listening to each other's stories and creating real connections does make peace, one relationship at a time. We individuals can make the world a better place every day by connecting with these precious people and listening to their stories. This is the first step in love and healing. As we do this as individuals, we create a grassroots peace movement that is unstoppable. It will spread to cover the land and even to break the rocky ground of hate and fear.

How can you join this peace movement? Reading "Learning to Listen to Palestine" by Lani Lanchester is a wonderful first step and guide into listening to Palestinians. Lani also encourages people, if they live in an urban area, to join a group and tell a Palestinian that you want to hear their story. They are likely to welcome you with love and tea!

Lani has found that local libraries are an amazing resource for forming these relationships. If there is not a Learning to Listen to Palestine group in your area, start one at your local library.

## Project 2025: The Latest Plot Against America

"Project 2025" has been winning an increasing amount of attention in its own right, but it's actually the opening salvo of "The 2025 Presidential Transition Project." This comprehensive playbook was produced under the auspices of the Heritage Foundation and supported by over 100 partner organizations. Officially titled "Mandate for Leadership: The Conservative Promise," its perverse genius lies in its sheer length—900 pages, much of it mindnumbing bureaucratic prose.

But ignore it at your peril. The massive tome is the latest iteration of a four-decade-long process of crafting right-wing policies to dismantle the federal government, deregulate industry and eliminate consumer protections and public health measures, while installing a regime controlled by fossil fuel interests and the Religious Right. Not coincidentally, the members of its advisory board have been making headlines attacking American institutions at a grassroots level, in preparation for the big takeover ranging from Moms4Liberty's assaults on local public schools, to the Koch-founded Institute on Energy Research's war on climate initiatives.

Project 2025 lays out specifics for hundreds of policy objectives affecting every area of public life. Many of them affect three primary areas: first, the dismantling of environmental regulations, clean energy measures, and climate policy; second, a rollback of civil and political rights for women and LGBTQ populations and the elimination of public health measures; and third, a massive purge of career civil servants and the concentration of power in the Executive branch in the White House, to consolidate an entrenched authoritarian regime. The following inventory of Project 2025 prescriptions is far from comprehensive, rather it is an attempt to highlight a few of the more alarming features.

## Here are ten things you need to know about Project 2025:

1.It's not just about Trump. Project 2025 specifically states that it does not depend on a Trump victory in November; it's explicitly directed at "the next conservative" or "the next GOP" occupant of the White House. Since its donors and partner organizations have achieved effective control of the Republican Party through purging moderates and promoting their supporters, it's unlikely that any Republican candidate can successfully run without their support.

Translation: Cumulatively, these organizations control massive voting blocs, concentrated among evangelical Christians, and coordinate extensive and carefullyorchestrated disinformation media that spreads, most concerningly, across battleground states.

2.It's not new. Project 2025 builds on a longstanding series of "Mandates for Leadership," going back to the Reagan Administration in 1981. The authors claim that Ronald Reagan and Donald Trump both implemented over half of their previous recommendations. Thanks to their inroads in federal court appointments during the Trump

Administration, they are now in the position to implement far more.

Translation: The Project 2025 partner organizations have been putting the squeeze on every Republican president since Reagan, and have often been disappointed. They met with unprecedented success with Donald Trump, and have no intention of giving up their

This project was bought and paid for with funding from the Koch Network and Leonard Leo. Although the names of the over 100 supporting organizations are trimmed with terms such as "freedom," "public," and "independent," over a third of them receive funding from the Koch Network, the driving force in advancing climate denial in the US.

(According to a review of IRS filings by Ralph Wilson of the Corporate Genome Project, a partial list of Koch Network beneficiaries include the Alabama Policy Institute, Alliance Defending Freedom, American Commitment, American Council of Trustees and Alumni, American Juris Link, American Legislative Council [ALEC], Citizens Against Government Waste, Claremont Institute, Competitive Enterprise Institute, Concerned Women for America, Ethics and Public Policy Center, Family Policy Alliance, Foundation for

Government Accountability, Heartland Institute, Heritage Foundation, Hillsdale College, Independent Women's Forum, Institute for Energy Research, Intercollegiate Studies Institute, James Madison Institute, Leadership Institute, Liberty University, Mackinac Center, Mississippi Center for Public Policy, National Association of Scholars, Oklahoma Council of Public Affairs, Pacific Research Institute, Patrick Henry College, Susan B. Anthony Pro-Life America, Tea Party Patriots, and the Texas Public Policy Foundation.)

Some two-thirds of the groups are funded by Leonard

Leo philanthropies, powered by a \$1.6 billion war chest from Chicago billionaire Barre Seid. Leo, a leading figure of the Catholic right, has led the initiative to install conservative judges in the US federal courts and played a pivotal role in overturning Roe. Recipients of Leo's funding include Leo's own Marble Freedom Trust (Leonard Leo, chairman); the Teneo Network (Leonard Leo, chairman) and the 85 Fund (a Leo funding hub).

The Koch Network and Leo funding regimes overlap in many cases, including through Donors Trust, a massive dark money donor-advised fund. Not coincidentally, Leo, Donors Trust CEO Lawson Bader, and the directors of a large percentage of the supporting organization are members of the Council for National Policy, the secretive umbrella organization that coordinates the activities of rightwing donors, media, and front organizations. William Walton, President of the CNP from 2020-2022, is the lead author on the chapter on the Treasuryanslation: The best autocracy money can buy.

## 3. According to Project 2025's website, the recommendations constitute the first of "four pillars" of a 180-day plan.

The implementation of the first step, or "policy agenda," corresponds to Trump's promise to be "dictator for a day" and issue a sweeping round of executive orders. This would include the reimposition of Schedule F, removing civil service protection from tens of thousands of federal employees and replacing them with political allies.


The second pillar, currently underway, is the compilation of a "Personnel Database" to "cast a net across the country to identify conservatives from all walks of life to serve in the next conservative administration"- known as "Linked-In for the Right."

The third pillar is a "Presidential Administration Academy," also currently underway, which offers online and in-person certificate programs for recruits to "start implementing the President's agenda from Day One."

The fourth pillar, the "180-Day Playbook," involves "a concrete, comprehensive action plan for each federal agency." This would be implemented by former members of the Trump Administration (many of whom are listed as authors of chapters concerning their agencies). along with the newly recruited "army" of militants.

Translation: This is not a drill: the MAGA Plan is

## **Principal Policy Initiatives:** Some Specifics

4. Climate, Environment, and Energy: Recommendations regarding energy, climate and the environment are dispersed among a number of chapters. The authors of these chapters are telling. The lead author for the chapter concerning the Department of Energy is Bernard McNamee, a former member of the Federal Energy Regulatory Commission under the Trump administration, an advisor to Ted Cruz, and a member of the Federalist Society. The lead author for the chapter on the Environmental Protection Agency served in the agency under Scott Pruitt, the former energy industry lobbyist who served as EPA Administrator under Trump and resigned under a cloud of ethics scandals and charges of gross mismanagement.

Plan 2025's recommendations on climate and energy, which would withdraw the United States from the Paris Climate Agreement, and expand fossil fuel drilling and consumption, also include:

"Rollbacks. A new Administration must immediately roll back Biden's order, reinstate the Trump-era Energy Dominance Agenda, rescind [Department of the Interior] Secretarial Order 3398 [on protecting public health and restoring science to tackle the climate crisis] and review all regulations, orders, guidance documents, policies, and similar agency actions made in compliance with that

"Reinstate order." (p. 521)

President Trump's plan for opening most of the National Petroleum Reserve of Alaska to leasing and development."

(p. 524) A school lunch tray with all the MyPlate food groups recommended by the **Department of** Agriculture, Proiect 2025 would eliminate free school meals.

"End the focus on climate change and green subsidies.... Eliminate energy efficiency standards for appliances.... [which currently include] air conditioners, furnaces, water heaters, stoves, clothes washers and dryers, refrigerators, dishwashers, light bulbs, and shower heads." (p. 378)

"The Clean Energy Corps is charged with investing more than \$62 billion to deliver a more equitable clean energy future for the American people.'....New Policies: Eliminate the Clean Energy Corps by revoking funding and eliminating all positions and personnel hired under the program." (p. 386)

"The next Administration should eliminate the Climate Hub Office and withdraw from climate change agreements that are inimical to the prosperity of the United States.... [and] withdraw the U.S. from the U.N. Framework Convention on Climate Change and the Paris Agreement."

"USAID should cease its war on fossil fuels in the developing world and support the responsible management of oil and gas reserves as the quickest way to end wrenching poverty and the need for open-ended foreign aid. The next conservative Administration should rescind all climate

## **Translation:**

So much for the birds, the bees, and the endangered species. That could eventually include us.

5. Public Health. The recommendations concerning health are dispersed among the introduction and various chapters. Together, they argue for an abandonment of the government's role in promoting public health for American children and adults. The author of the foreword is Heritage President Kevin Roberts and the chapter on the Department of Health and Human Services is Roger Severino, a former Trump appointee who previously served as the director of the DeVos Center at the Heritage Foundation. His wife. CNP member Carrie Severino, who clerked for Clarence Thomas, currently heads the Judicial Crisis Network, which coordinates efforts with Leonard Leo on federal court appointments.

Roberts' foreword launches a full-bore assault on LGBTQ and reproductive rights, in an Orwellian exercise seeking to erase the very vocabulary of social progress from the national discourse.

institutions of American civil society hard targets for woke culture warriors. This starts with deleting the terms sexual orientation and gender identity ('SOGI'), diversity, equity, and inclusion ('DEI'), gender, gender equality, gender awareness, gender-sensitive, abortion, reproductive health, reproductive rights, and any other term used to deprive Americans of their First Amendment rights out of every federal rule, agency regulation, contract, grant, regulation. and piece of legislation that exists." (p. 4-5)

**Translation:** Forget the goal of "health" if it involves female organs.

Not surprisingly, Severino's first stated goal is to "protect the fundamental right to life." "Goal #4: Preparing for the Next Health Emergency" codifies COVID disinformation (such as the claim of "excess deaths" due to lockdowns, etc.), and seeks to disable the Centers for Disease Control's ability to advise the public on measures for disease control.

"The COVID-10 pandemic demonstrated how catastrophic a micromanaging, misinformed, centralized, and politicized federal government can be. Basic human rights, medical choice, and the doctor-patient relationship were trampled without scientific justification and for extended periods of time. Excess deaths, not due to COVID-19, skyrocketed because of forced lockdowns, isolation, vaccine-related mass firings, and colossal disruptions to the economy and daily rhythms of life... Unaccountable bureaucrats like Anthony Fauci should never again have such broad, unchecked power to issue health "guidelines" that will certainly be the basis for federal and state mandates." (p. 451-452)

**Translation:** "Excess deaths, not due to COVID-19, skyrocketed" never happened. But why quibble over details.

The chapter even seeks to prohibit the CDC from advising the vaccination of schoolchildren. (As of March 3, outbreaks of measles, a potentially deadly disease easily avoided through vaccination, have been reported in 17

"By statute or regulation, CDC guidance must be prohibited from taking on a prescriptive character. For example, never again should CDC officials be allowed to say in their official capacity that school children 'should be' masked or vaccinated (through a schedule or otherwise) or prohibited from learning in a school building." (p. 454)

Translation: The Centers for Disease Control should be prohibited from attempting to control disease. Thanks to anti-vaxxing campaigns, we now confront rampant

outbreaks of measles, with a statistical likelihood of 1-2 preventable deaths per 1000 children. Is polio far behind?

**6. Plan 2025's "Family Agenda"** also has profound implications for the health and safety of children, which would evidently constrain child protective services, foster homes, and adoption for children at risk:

"The Secretary should proudly state that men and women are biological realities that are crucial to the advancement

of life sciences and medical care and that married men and women are the ideal natural family structure because all children have a right to be raised by the men and women who conceived them." (p. 489)

"Promoting Life and Family. In dealing with sexually transmitted diseases and unwanted pregnancies, the OASH (Office of the Assistant Secretary for Health) should focus on root-cause analysis with a focus on strengthening

marriage and sexual risk avoidance." (p. 490)

**Translation:** Limiting parenting to "the men and women who conceived them" would eliminate adoption and foster homes for abused children, to say nothing of "unnatural family structures." Also, marriage has traditionally proven to be an unreliable cure for syphilis.

The chapter on the Department of Labor includes one of various measures designed to roll back the rights of LGBTQ populations:

"Rescind regulations prohibiting discrimination on the basis of sexual orientation, gender identity, transgender status, and sex characteristics." (p. 584)

**Translation:** Allow LGBTQ individuals to be fired without cause. And what are "sex characteristics"?

Other chapters seek to eliminate Department of Agriculture's role in promoting nutrition and food safety inspection, and additional measures to promote occupational safety.

The next Administration should "promote legislation that would allow state-inspected meat to be sold in interstate commerce. These barriers to the sale of meat and poultry from USDA-approved state-inspected facilities should be removed." (p. 305)

**Translation:** Let's let Sarah Huckabee Sanders' Arkansas hog and poultry inspectors decide on food safety for the rest of us.

"Eliminate or Reform the Dietary Guidelines. .... Nutrition and dietary choices are best left to individuals to address their personal needs.... The next Administration should: Work with lawmakers to repeal the Dietary Guidelines. (p. 309)

**Translation:** Because with 40 percent of Americans obese and 70 percent overweight, we're obviously getting

adequate nutritional guidance—as reflected by our declining life expectancy (trailing Macao, the Maldives, and Kosovo).

"Congress should: ...Repeal the Dodd-Frank mandated disclosures relating to conflict minerals, mine safety, resource extraction, and CEO pay ratios." (p. 832)

**Translation:** Because occupational safety could affect CEO pay ratios?

7.Plan 2025 calls for the concentration of powers in the White House. The chapter on the "White House

Office" was written by Rick Dearborn, formerly Trump's Deputy Chief of Staff. It anticipates legal challenges to the wholesale withdrawal of regulatory measures, and calls for preemptive legal action.

"To offer guidance, the White House Counsel must get up to speed as quickly as possible on all significant ongoing legal challenges across the executive branch that might affect the new Administration's policy agenda and must be prepared at the

outset of the administration to present recommendations to the president including recommendations for reconsidering or reversing positions of the previous Administration in any significant litigation."(p. 28)

The chapter on the Department of Justice also calls for expansion of presidential powers. It was written by Gene Hamilton, who formerly served in Trump's DOJ. He is the general counsel of the America First Legal

Foundation, co-founded with former White House advisor Stephen Miller. Hamilton calls for the conversion of the FBI into a political instrument of the President:

"The next conservative the rights of LGBTQ populations. Administration should direct

the Attorney General to remove the FBI from the Deputy Attorney General's direct supervision within the department's organizational chart and instead place it under the general supervision of the Assistant Attorney General for the National Security Division, as applicable.... Such a structure would...place the FBI under a politically accountable leader with fewer things to manage than the Deputy Attorney General or the Attorney General have." (p. 549-50)

**Translation:** There will be lawsuits, but with an army of White House lawyers and the FBI acting as a White House security force, these can be dealt with.

8. In a break from precedent, the chapter on the State Department calls for a preemptive mass disruption of the diplomatic corps, and the immediate installation of loyalists in place of career diplomats, without regard for security clearances and other protocols—a recipe for chaos. The chapter also calls for a "freeze" on international treaties,

disbursements, etc.

"Reboot Ambassadors Worldwide. All ambassadors are required to submit letters of resignation at the start of a new Administration. Previous Republican Administrations have accepted the resignations of only the political ambassador and allowed the foreign service ambassadors to retain their posts, sometimes for months or years into a new Administration. The next Administration must go further. It should both accept the resignation of all political ambassadors and quickly review and reassess all career ambassadors. This review should commence well before the new Administration's first day. Ambassadors in countries where U.S. policy or posture would substantially change under the new Administration, as well as who have evinced hostility toward the incoming Administration or its agenda, should be recalled immediately. The priority should be to put in place new ambassadors who support the President's agenda among political appointees, foreign service officers, and civil service personnel, with no predetermined percentage among these categories." (p. 174)

**Translation:** Career foreign service officers can join their fellow civil servants in the bread line, and cronies can take their place. What could possibly go wrong?

"Before inauguration, the President-elect's department transition team should assess every aspect of State Department negotiations and funding commitments. Upon inauguration, the Secretary of State should order an immediate freeze on all efforts to implement unratified treaties and international agreements, allocation of resources, foreign assistance disbursements, domestic and international contracts and payments, hiring and recruiting decisions, etc., pending a political appointee-driven review to

ensure that such efforts comport with the new Administration's policies." (p.174)

**Translation:** Continuity in foreign policy be damned. Our allies won't mind because we won't have any.

Plan 2025 contains relatively

little material on foreign policy, but what it does include is concerning. "Ending economic engagement" with China would collapse the economy (as opposed to the current policy of gradually diversifying supply chains); likewise, it's hard to imagine that including Russia in the "Europe, Eurasia, and Russia region" will contribute usefully to the "global security architecture" under the current international situation.

"Economic engagement with China should be ended, not rethought." (p. 13)

**Translation:** "Ending" trade with China would collapse the global economy. But whatever.

"American foreign policy has long benefited from cooperation with the countries of Europe (generally, the EU), and any conservative Administration should build on this resource. Yet the transatlantic relationship is complex, with security, trade, and political dimensions. First, the

Translation: Inviting the "Russia region" to "bear a fair share" of "global security architecture" may be a tell. Goodbye NATO.

9. The chapter on the Department of Homeland Security was written by CNP member Ken Cuccinelli, who used his position in the department under the Trump administration to restrict immigrant rights. It calls for limiting cybersecurity and anti-disinformation efforts, especially "closer to an election." It also mislabels the findings of the Mueller Report regarding Russian election interference as a "Clinton campaign 'dirty trick."

"Prohibit the FBI from engaging, in general, in activities related to combating the spread of so-called misinformation and disinformation by Americans who are not tied to any plausible criminal activity." (p. 550)

expenditures allocated by Congress. But the Trump Administration succeeded in reversing a large number of environmental regulations during Scott Pruitt's tenure at the Environmental Protection Agency, as well as other protective measures that have been restored by the Biden Administration. The Trump Administration took measures against the Department of Agriculture's research divisions on climate science, food assistance, and tax policy by moving them to Kansas City, losing half of the staff, and these divisions are still recovering.
